



MogoCrypto Terms & Conditions

These MogoCrypto Terms and Conditions (this “Agreement”) are a legally binding agreement between Mogo Blockchain Technology Inc. (“Mogo”, “we”, “our” or “us”) and your awesome self (“you”, “yours” or “your”) that describe the terms that you agree to when using MogoCrypto through the MogoAccount at www.mogo.ca (the “Mogo Website”) or the Mogo app (the “Mogo App”) as owned and operated by Mogo and its subsidiaries and/or affiliates.

We’re saying goodbye to MogoCrypto for now.

Effective October 13, 2022 we are no longer offering MogoCrypto to new users and existing MogoCrypto users will no longer be able to fund their MogoCrypto account or purchase bitcoin. Existing MogoCrypto users who have bitcoin holdings in their Bitcoin Account will have until 5:00 PM EST on December 12, 2022 (the “Action Deadline”) to sell and withdraw their holdings, or alternatively, transfer their bitcoin holdings to an account at Coinsquare. If you do not sell and withdraw or transfer your bitcoin holdings by the Action Deadline, then Mogo will liquidate your holdings. Mogo does not and cannot make any guarantee regarding the price of bitcoin at the time your bitcoin may unilaterally be sold by Mogo in the event you do not sell and withdraw or move your bitcoin holdings prior to the Action Deadline. Mogo will not be liable for any losses you may suffer if the price of bitcoin decreases. Neither Mogo nor its Exchange Partner will compensate you for the loss in value of your holdings.

IN ADDITION TO THE DISCLAIMERS OF LIABILITY SET OUT IN SECTION 10 OF THESE TERMS, MOGO EXPLICITLY DISCLAIMS ANY AND ALL LIABILITY FOR ANY AND ALL LOSSES YOU MAY SUFFER AS A RESULT OF THE DISCONTINUANCE OF THE MOGOCRYPTO PRODUCT INCLUDING, WITHOUT LIMITATION: (A) ANY GAINS OR LOSSES THAT YOU MAY INCUR AS A RESULT OF CHOOSING TO SELL YOUR BITCOIN OR AS A RESULT OF ANY SALE ON YOUR BEHALF BY MOGO; (B) ANY LOSS OF OPPORTUNITY, FEES OR CHARGES; (C) ANY LOSS RESULTING FROM YOUR FAILURE TO SUBMIT CORRECT OR ACCURATE INFORMATION TO MOGO IN CONNECTION WITH THE TRANSFER OF YOUR BITCOIN HOLDINGS TO COINSQUARE, THE WITHDRAWAL OF FIAT TO YOUR BANK ACCOUNT, OR OTHERWISE; (D) ANY LOSS, COST OR DAMAGE THAT RESULTS FROM ANY INABILITY TO SELL YOUR BITCOIN HOLDINGS USING MOGOCRYPTO DUE TO TECHNICAL LIMITATIONS AFTER INITIATING A TRANSFER TO COINSQUARE DUE TO ANY HOLD PERIOD WHICH MAY BE IMPLEMENTED DUE TO A PENDING

TRANSFER; (E) ANY LOSS RELATED TO THE LIQUIDATION OF YOUR BITCOIN HOLDINGS AS A RESULT OF YOU BEING INELIGIBLE FOR A COINSQUARE ACCOUNT; AND/OR (F) ANY OTHER SIMILAR LOSS.

Mogo's Privacy Policy and Security Practices and our Terms of Use and MogoAccount Terms and Conditions, available [here](#) and [here](#), respectively, are incorporated by reference into this Agreement. This means that by accepting this Agreement, you also accept and agree to be bound by Mogo's Privacy Policy and Security Practices and Terms of Use and MogoAccount Terms and Conditions.

"Exchange Partners" means those cryptocurrency exchanges that Mogo has entered into agreements with and through which Mogo makes cryptocurrencies available to its members for purchase through MogoCrypto. As of the date of this Agreement, our only exchange partner is Coinsquare Ltd.. All references to "Cash" or "dollars" are references to lawful money of Canada.

As of October 13, 2022, these Terms and Conditions continue to apply to existing MogoCrypto users subject to the functionality limitations described above.

Acceptance of Agreement

You may not use MogoCrypto or accept this Agreement unless you are the age of majority in the province or territory in which you reside and are legally able to accept and be bound by this Agreement. MogoCrypto is currently available for residents of all of Canada (excluding Quebec).

You must read and agree to this Agreement in its entirety before you use the MogoCrypto. IF YOU DO NOT AGREE TO THIS AGREEMENT YOU MUST NOT USE MOGOCRYPTO.

MOGO RESERVES THE RIGHT TO CHANGE, UPDATE, ADD OR REMOVE ANY OR ALL PROVISIONS OF THIS AGREEMENT AT ANYTIME BY POSTING THOSE CHANGES ON THE MOGO WEBSITE. YOUR CONTINUED USE OF THE MOGOCRYPTO SERVICES AMOUNTS TO ACCEPTANCE OF ANY SUCH CHANGES.

Please note that the titles and subtitles used throughout this Agreement are intended to help organize and create a more user-friendly reading experience but should not be construed as a complete summary of each section of this Agreement.

1. Risks and Limitation of Liability

aka **WARNING! WARNING! WARNING!** and **DON'T SAY WE DIDN'T TELL YOU SO!**

The price of bitcoin and other cryptocurrencies is very volatile. Prices may increase or decrease significantly in very short periods of time. This means that there is a potential for huge losses when buying or selling bitcoin or other cryptocurrencies, and from cybersecurity breaches/theft of cryptocurrencies and private keys stored on cryptoexchanges. In fact, these risks have materialized previously in other cryptoexchanges. You should only invest money that you are willing to lose and should never borrow money to purchase cryptocurrency. Mogo will not provide you with any advice or recommendations for buying or selling cryptocurrency. You should do your own research before buying or selling any cryptocurrency including, but not limited to, consulting with qualified independent financial advisers.

YOU ACKNOWLEDGE THAT YOU USE MOGOCRYPTO AT YOUR OWN RISK. YOU AGREE THAT MOGO AND MOGO'S EXCHANGE PARTNERS WILL NOT BE LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, PUNITIVE, EXEMPLARY, SPECIAL OR CONSEQUENTIAL LOSS OR DAMAGES, HOWEVER CAUSED, THAT YOU MAY SUFFER AS A RESULT OF YOUR USE OF, ACCESS TO, OR INABILITY TO ACCESS MOGOCRYPTO, INCLUDING WITHOUT LIMITATION: (1) ANY INCREASE OR DECREASE IN PRICE OF CRYPTOCURRENCY; (2) ANY LOSS OR THEFT OF CRYPTOCURRENCY, FIAT CURRENCY, YOUR PRIVATE OR PUBLIC KEYS, OR ANY CREDENTIALS; (3) ANY ALLEGED LOSS OF OPPORTUNITY; (4) THE USE OR THE INABILITY TO USE ANY CRYPTOCURRENCY PURCHASED VIA MOGOCRYPTO; (5) THE COST OF PROCUREMENT OF SUBSTITUTE GOODS OR SERVICES; OR (6) ANY OTHER PECUNIARY OR NON-PECUNIARY LOSS THAT YOU MAY SUFFER AS A RESULT OF USING, OR NOT USING, MOGOCRYPTO, IN EACH CASE WHETHER DUE TO MOGO OR MOGO'S EXCHANGE PARTNERS' NEGLIGENCE OR OTHERWISE.

MogoCrypto is available for use on an "as-is" and best-efforts basis. Mogo provides no guarantees with respect to the service and will not be liable for any interruptions or disruptions in service, howsoever caused.

To access MogoCrypto, you will need an internet connection and electronic communications. Mogo will not be responsible for any delays, failures or losses that you may suffer if things such as your internet connection, electronic device or electronic communication service encounters problems or fails.

What does this actually mean for you?

While Mogo wants to give its members the opportunity to buy and sell cryptocurrency, Mogo isn't willing to give you any advice on whether or not you should buy or sell cryptocurrency or provide any assurance or guarantee that you will not lose everything. Buying and selling cryptocurrency is extremely risky. We expect you to be a responsible

user of MogoCrypto, to do your own research and to make your own decisions about whether or not you want to buy or sell cryptocurrency at any given time. If you want advice, then we encourage you to seek out independent financial advice from a qualified investment professional.

If you choose to buy or sell cryptocurrency through MogoCrypto and you lose the cryptocurrency, Cash or anything else for any reason, including theft or loss of the cryptocurrency or keys, neither Mogo nor any of our Exchange Partners will be responsible for these losses, period. If this freaks you out, just don't use MogoCrypto. Our lawyers would hate to have to be the ones to say we told you so.

2. Description of Services and Pricing aka WHAT IS MOGOCRYPTO?

MogoCrypto is not an exchange. Mogo has entered into agreements with Exchange Partner(s) in order to facilitate the purchase and sale of cryptocurrencies by MogoMembers from within the MogoAccount. To use MogoCrypto, you must first become a MogoMember, meet all of the eligibility requirements set out herein and otherwise read and agree to this Agreement in its entirety. You must transfer Cash to MogoCrypto using one of the accepted methods set out below. Thereafter, you may use that Cash to buy cryptocurrency, you may sell your cryptocurrencies for Cash, or you may withdraw Cash to your Canadian bank account, as set out below. Any cryptocurrency you buy and your private key(s) is held by our Exchange Partner(s) in 95% cold storage. MogoCrypto does not hold or store your cryptocurrency and your private key(s).

Funding MogoCrypto

As of October 13, 2022, funding is no longer available.

In order to buy or sell cryptocurrencies, you must fund MogoCrypto with Cash.

Interac Request - Instant: If you fund MogoCrypto using Interac Request - Instant, then Mogo will use commercially reasonable efforts to process and fund your MogoCrypto CAD holdings instantly. In the event of a heavy volume of transactions or in the event Interac suspects any funding requests to be suspicious or fraudulent, it may take longer to process and fund MogoCrypto. Mogo will not be liable for any delay in the funding of MogoCrypto.

Rejected funding: We reserve the right to reject your funding request for any reason including if the name on your bank account doesn't match the name in your MogoAccount or if you haven't otherwise followed the funding instructions set out in the MogoCrypto dashboard, including the applicable limits. If we do reject your funding request, then we will return your Cash to you by the same funding method that you used or by mailing you a cheque in our sole discretion. In order for us to return the Cash to you, you must provide us with your bank account information, wire transfer information, or mailing address. If, for any reason, Mogo rejects your funding request then Mogo will not be liable for any

fees or charges that you have already paid or may be required to pay to your financial institution.

Funds may be delayed or services unavailable based on certain factors and Mogo will not be responsible for any losses arising from a delay or failure to fund your MogoCrypto CAD holdings or execute your buy transaction. While Mogo does not charge any fees on certain funding methods, the supported funding method that you select may charge fees that you will be solely responsible for. Once Mogo has processed and funded MogoCrypto with your Cash, you may buy cryptocurrencies immediately.

You may fund MogoCrypto with Cash by using the following funding methods, subject to the applicable limits set out below:

Mogo reserves the right to add, remove or change available funding methods at any time without notice. Your financial institution may charge you a fee for Interac Request - Instant. Mogo will not be responsible for any fees or costs that you may incur in funding MogoCrypto including, but not limited to, any fees charged by Interac.

Cash Holdings

“Cash Holdings” means the amount of Cash held in MogoCrypto and available to use for the purpose of buying cryptocurrencies. Your Cash Holdings are held on your behalf at a Schedule 1 Canadian Bank in one or more trust accounts in the name of, and managed by, our Exchange Partner(s). Your current cash balance is displayed in your MogoAccount. Your Cash Holdings are not insured on your behalf by the Canada Deposit Insurance Corporation or any other deposit insurer.

Withdraw Hold

Mogo may, in its sole and absolute discretion, block on your ability to withdraw Cash that you use to fund MogoCrypto from MogoCrypto for such time as Mogo deems necessary (the “Withdraw Hold”). You will only be able to withdraw the amount you funded in Cash to a verified Canadian bank account after the applicable Withdraw Hold period has ended.

Withdrawals and Bank Account Verification

Before you withdraw Cash from your Cash Holdings to your Canadian bank account, Mogo must verify your Canadian bank account registered in your name. The first time you withdraw Cash to a particular bank account, you will be required to verify that bank account. To start the bank account verification process, you must provide Mogo with your bank account details, including: bank name, institution number, transit number and account number. Mogo may refuse to verify your bank account at its sole discretion, including if the owner’s name on the bank account does not match the name on your MogoAccount. Mogo may, in its sole discretion, require you to complete additional security, identity, and/or other verification steps when you conduct any withdrawal.

Once your bank account has been verified by Mogo, you may withdraw your “Available Balance”, which includes all Cash that is not subject to an outstanding Withdraw Hold, subject to the applicable withdraw limits. Mogo will make commercially reasonable efforts to schedule an electronic funds transfer to your bank account within 24 hours of receiving your request for withdrawal. Depending on your financial institution, it may take 1-5 additional business days for your financial institution to process this transfer.

It is your responsibility to enter the correct account information for withdrawals. Mogo will not be responsible for any delays in depositing Cash to your bank account or for any Cash deposits sent to any incorrectly verified bank accounts provided by you to Mogo. All such withdrawals are irreversible and you will be responsible for any recovery of funds due to error. All withdrawals are subject to applicable limits as set out below:

Supported Cryptocurrencies

Cryptocurrencies are listed on MogoCrypto at the discretion of Mogo and can be removed or closed at any time. Currently, bitcoin is the only supported cryptocurrency. If a cryptocurrency is so removed or closed, your open orders will be cancelled and your account credited back. If a cryptocurrency is selected for removal, and if the applicable blockchain allows it, you will have twenty-five (25) days to sell your cryptocurrency and withdraw your Cash. If you do not sell the cryptocurrency within such time, you authorize Mogo to sell the cryptocurrency for Cash thereafter at its discretion, and added to your Cash Holdings. Mogo and its Exchange Partners assume no liability or cost whatsoever arising from removed or closed cryptocurrency, including any loss in value resulting from the timing of the sale of a cryptocurrency that is no longer supported.

Buying & Selling Cryptocurrencies

Effective October 13, 2022, buying cryptocurrencies is no longer available.

To buy cryptocurrencies, you must request a quote by entering the value of cryptocurrency in Cash that you wish to buy or sell. Thereafter, you will be shown a confirmation page with a summary of the transaction, including the current rate for that cryptocurrency as retrieved from our Exchange Partner(s). If you choose to accept the quote and buy or sell that cryptocurrency at the quoted rate, then Mogo will use commercially reasonable efforts to complete the action of buying or selling cryptocurrencies with our Exchange Partner(s) at the quoted rate. Your ability to buy or sell cryptocurrencies is dependent on market conditions. The executed rate may differ slightly from the quoted and confirmed rate and any price difference you may see between the estimated price on the confirmation page and the actual execution price is due to market movement.

You understand that our Exchange Partner(s) may, at their sole discretion, decline your buy or sell transaction. If your buy or sell transaction is declined by our Exchange Partner(s), then the original quote for your buy or sell transaction will expire and you will need to request a new quote to proceed. Mogo and its Exchange Partners will not be liable for any losses that you may suffer as a result of our Exchange Partner declining your buy or sell transaction

All buy or sell transactions confirmed by you are final and are non-reversible. You will have one opportunity to confirm your order before finalizing it. Mogo and its Exchange Partners will not be responsible for losses caused by mistyped or wrongly placed orders. An open order may be cancelled at any time by you but Mogo and its Exchange Partners make no guarantee on whether that order will be cancelled before execution.

Cryptocurrency Pricing

The exchange rate we offer you on a buy or sell transaction of cryptocurrency is calculated from our Exchange Partner's price, which may include fees or mark-ups applied by our Exchange Partner and/or other factors such as market depth and volatility, and includes a 1% fee charged by us. You can check the exchange rates we offer for cryptocurrency purchases and sales at any time from within the MogoAccount.

Cryptocurrency Holdings

Mogo displays the approximate value of your cryptocurrency holdings in Cash using the current mid-market price of the actual amount of cryptocurrency you own. All of your cryptocurrency holdings in MogoCrypto are held in 95% cold storage with our Exchange Partner(s). You will not be able to see or copy your private key which is stored by our Exchange Partner(s). **YOU MAY NOT TRANSFER YOUR CRYPTOCURRENCY HOLDINGS FROM MOGOCRYPTO INCLUDING TO ANY OTHER WALLET OR EXCHANGE, UNLESS OTHERWISE EXPLICITLY PERMITTED TO DO SO BY MOGO.**

Total Holdings

For the purposes of MogoCrypto, “Total Holdings” means the value equal to the sum of your Cash Holdings plus the Cash value of your cryptocurrency holdings using the current mid-market price.

Transaction History

You may view your transaction history from within your MogoAccount. Your transaction history is divided into two groups of transactions: (a) Buy & Sell and (b) Fund & Withdraw. All transactions are displayed using the time zone you have selected within your MogoAccount settings.

Buy and Sell transactions are organized by date of quote execution and provide details such as the value of the transaction in Canadian dollars, amount of cryptocurrency and the quoted price of the cryptocurrency at the time the transaction was executed.

Fund and Withdraw transactions are organized by date. For Fund transactions, the date displayed reflects the date that Cash was added to MogoCrypto Cash Holdings. For Withdraw transactions, the date displayed reflects the date that you requested the withdraw of Canadian dollars to your verified Canadian Bank Account. For both Fund and Withdraw transactions the value of Cash is displayed on a per transaction basis.

3. Permitted Users, Licenses and Laws aka WHO CAN USE MOGOCRYPTO?

Effective October 13, 2022, MogoCrypto is no longer available to new users.

In order to use MogoCrypto, you must:

- (a) Be a Canadian resident (excluding residents of Quebec);
- (a) Be the age of majority in your province or territory of residence;
- (b) Be a MogoMember that:
 - a. has passed Mogo’s Know Your Client (“KYC”) requirements;
 - b. has been granted access to the MogoAccount dashboard;
 - c. has not otherwise been flagged for actual or suspected fraudulent activity by Mogo in its sole and absolute discretion;
 - d. is not in default of your obligations with respect to any one or more of the products and services available through the MogoAccount.

(c) Represent and warrant that you have a sufficient understanding of cryptocurrencies to allow you to understand each purchase or sale of cryptocurrency that you make; and

(d) Comply with this Agreement.

You agree to maintain and update your personal information in your MogoAccount from time to time as necessary to ensure that it is always up to date.

You agree to abide by all applicable laws in connection with your use of MogoCrypto including those related to intellectual property rights, data privacy, international communications and the transmission of technical or personal data.

Mogo grants you a limited, non-exclusive, non-transferrable license, subject to this Agreement, to access and use MogoCrypto solely for approved purposes as permitted by Mogo from time to time. All rights not expressly granted in this Agreement are reserved by Mogo.

4. User Acknowledgments

aka THE PROMISES THAT YOU MAKE TO MOGO

In exchange for us letting you use MogoCrypto, we need you to promise us some things. So, by using MogoCrypto, you warrant and agree that:

(a) The cryptocurrencies available through MogoCrypto are not “securities” within the meaning of any securities legislation in Canada and you will not have available to you any of the rights, remedies or protections that would otherwise be available to purchasers of securities;

(b) You understand the risks and implications associated with buying and selling cryptocurrency and you are willing to take those risks;

(c) You understand that neither Mogo nor its Exchange Partners make any representations or warranties with respect to the cryptocurrencies available for purchase via MogoCrypto and that you are solely responsible for researching the cryptocurrencies that you purchase or sell and ensuring that your purchases and sales are made on an informed basis;

(d) You understand holding cryptocurrencies carries various risks, including those relating to the technology underlying the cryptocurrencies and the value of your cryptocurrencies may decrease to zero;

(e) The cryptocurrencies that you may purchase through MogoCrypto are not insured and are not protected by any centralized agency;

- (f) The Canadian dollars that you use to fund purchases through MogoCrypto are not insured by the Canada Deposit Insurance Corporation or any other insurer;
- (g) Mogo and Mogo's Exchange Partners' ability to fulfill your purchase or sale order depends, in part, on the market for that cryptocurrency. If there is a lack of corresponding purchase or sale orders in a particular cryptocurrency at that time then it may not be possible for Mogo to fulfill your order in a timely basis, or at all;
- (h) MogoCrypto, Mogo's Exchange Partners' and Mogo services may be subject to malicious cyberattacks or contain exploitable flaws in its security systems, which may result in security breaches and the loss or theft of any or all of your cryptocurrencies or Canadian dollars;
- (i) Cryptocurrencies available for purchase via MogoCrypto may not be subject to ongoing public disclosure requirements and therefore it may be difficult to find accurate and current information, or any information at all, relating thereto. In addition, others trading in those cryptocurrencies may be doing so in possession of material and other information that has not been publicly disclosed. Cryptocurrencies generally do not afford the holder any rights commonly associated with securities ownership, such as voting rights and rights to participate in the equity of the issuer;
- (j) You completely understand and agree to abide and be bound by the terms of this Agreement;
- (k) You will adopt and implement commercially reasonable preventative procedures to ensure that you exercise commercially reasonable care and diligence not to pass any computer virus, worm, bug or other computer infection to Mogo or its Exchange Partners;
- (l) To the extent permitted by law, you waive your right to participate in any sort of class action or other lawsuit or arbitration against Mogo or its Exchange Partners;
- (m) You have done your research, sought out appropriate legal, financial and tax advice in connection with the cryptocurrency that you intend to purchase through MogoCrypto and that you will continue to seek out such advice as necessary on an ongoing basis so long as you use MogoCrypto;
- (n) Mogo and its Exchange Partners are not responsible for any consequences arising from false, incorrect or incomplete information that you provide to us;
- (o) Mogo and its Exchange Partners do not own or control, and make no representations or warranties with respect to, the underlying technology of the cryptocurrencies you may purchase or sell using MogoCrypto, including those technologies that govern their use;

- (p) The underlying technology of cryptocurrencies may suddenly change such that the new version is no longer compatible with existing versions or there is otherwise a permanent divergence of the blockchain (a “Fork”) which may impact the value, functionality and other characteristics such as the name of the cryptocurrency and whether MogoCrypto is able to support the cryptocurrencies subject to a Fork; and
- (q) Mogo and its Exchange partners are not responsible for any consequences arising from a Fork including any losses that you may suffer and, in the event of a Fork, Mogo or its Exchange Partners may temporarily suspend the operation of MogoCrypto, with or without advanced notice to you, and may, in their sole discretion, decide whether or not to support the cryptocurrencies subject to such Fork.

5. Prohibited Uses

aka YOU’LL BE IN BIG TROUBLE IF YOU DO ANY OF THIS

We want all of our MogoMembers to play nice when using MogoCrypto and we’re going to set out some ground rules. Below is a list of some examples of the things that you are not allowed to do while using MogoCrypto. There might be other things that you do that are not listed below that may cause us to terminate your account. If you are not sure if you are about to do something that is going to get you kicked out, please contact us.

Mogo and its Exchange Partners reserve the right to terminate your access to MogoCrypto if you do any of the following, or anything else that Mogo or its Exchange Partners, in their sole and absolute discretion, deems detrimental to MogoCrypto, other MogoMembers, its Exchange Partners or Mogo. Without limiting the generality of the foregoing, you may not:

- (a) Use MogoMoney to purchase cryptocurrency.
- (b) Access MogoCrypto for any benchmarking or competitive purposes, including any attempt to reverse engineer MogoCrypto and associated services.
- (c) Engage in any activity that would violate, assist in violation of, or relate to the violation of, any law, statute, regulation, or sanctions program administered by any level of government in Canada, including any transaction that would involve proceeds of any unlawful activity.
- (d) Undertake any activity that would amount to an abuse of MogoCrypto, in Mogo or its Exchange Partners’ sole and absolute discretion. This includes, but is not limited to, any actions that create and unreasonably large load on our infrastructure or that interfere with, intercept or expropriate our system, data or information or the security thereof. Further, you must not transmit or upload any material to MogoCrypto that contains any virus, trojan horse, worm, or other harmful or malicious program. You may not harvest, extract or otherwise collect any information from Mogo about Mogo, its Exchange Partners or any other person.

- (e) Engage in any activity intended to defraud or interfere with Mogo, Mogo users, Mogo's Exchange Partners or any other person, or the provision of any false, inaccurate or misleading information to Mogo.

7. Cancellation

aka CLOSING YOUR ACCOUNT

You can close your MogoAccount upon request in the manner set out in the MogoAccount Terms and Conditions.

8. Mogo's Termination Rights

aka WHEN CAN MOGO CANCEL THIS AGREEMENT IN GENERAL?

If Mogo, in its sole and absolute discretion, determines that you have violated this Agreement or suspects that your MogoAccount has been hacked or accessed without authorization, then Mogo reserves the right to terminate this Agreement with you immediately and without notice.

We may also suspend or revoke your MogoAccount without notice to you at any time for any reason, including if we are required to do so by law or by any of our third-party provider. This means that if you use our registered trademarks or other intellectual property without our knowledge or consent then our lawyers have to send you angry letters and do other things to stop you from doing it. Our lawyers are fun-loving people who hate to have to write angry letters so please, just don't use our trademarks or intellectual property without getting our permission first.
